Our public relations policy is based on attraction rather than promotion; we need always maintain personal ano-

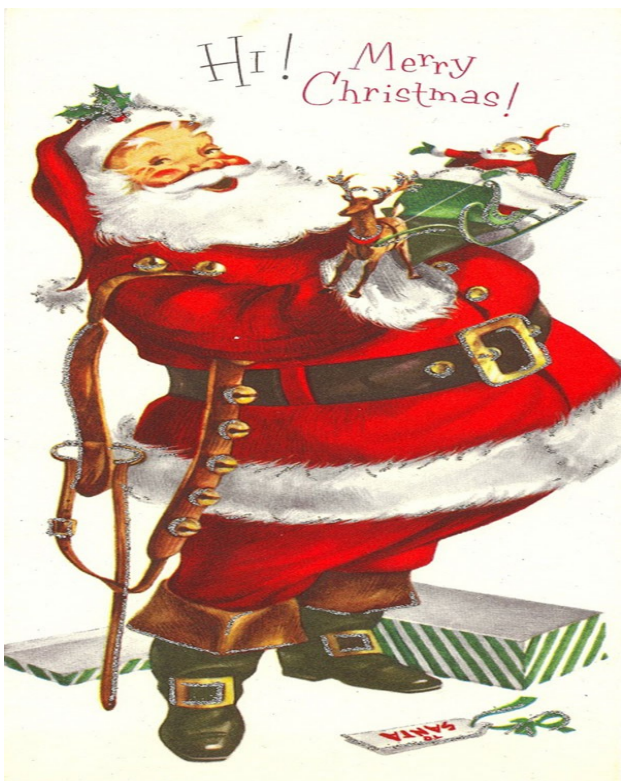


Step 12
